



GENERAL CONDITIONS OF SALE 2026

- The reservation becomes effective only after agreement of the campsite and after receiving the deposit.

- In case of non-payment of the deposit upon reservation or the balance no later than 30 days before the start date of the stay by the client, the campsite reserves the right to cancel the reservation and reoffer the accommodation or pitch for rent.

The campsite offers traditional holidays, in the traditional sense, accommodation and camping pitches are specially designed for this purpose. The campsite reserves the right to refuse any reservation that would be contrary to this principle, or that would seek to divert it.

- The reservation of a campsite or rental is strictly personal. You may in no case sublet or transfer your reservation without the prior consent of the campsite.

Minors must be accompanied by their parents whether in rental or camping accommodation. Otherwise, the reservation will be refused and the deposit refunded.

- The rental is personal, it is forbidden to sublet or transfer the site to a third party.

RENTING

The rental accommodations are equipped. The basic rate varies from 4 to 6 beds depending on the type of rental.

- Saint-Aygulf Campsite reserves the right to refuse access to the campsite to groups or families arriving with a higher number of participants than the capacity of the accommodation or rented site.

- The booking fees are €25 per reservation and €20 per campsite pitch.

- The accommodations and pitches proposed on the campsite's website are

addressed exclusively to a diverse clientele.

- For any group booking request of more than 3 rentals or more than 2 locations, you must contact the campsite by phone, email or via our section «We Contac-ter». The campsite will study the booking request and reserve the right to accept or refuse it.

- The prices indicated are valid for the current note. They correspond to one night for the camping pitches and one week for the rentals. The rates are in euros, VAT included and excluding tourist taxes, eco participation and booking fees.

- The amount of the tourist tax, at the legal rate in force, per day/person over 18 years old.

- The amount of the Eco Participation is 1.14 € per day and per person for the financing of wastewater, collection, treatment, recycling, and end-of-life waste recovery.

- For reservations made, a deposit of €150/week + €25 booking fee for rentals and €100 deposit + cancellation insurance if taken out + €20 booking fee for camping pitches must be paid upon reservation.

The balance must be paid no later than 30 days before the start date of the stay.

- For reservations made less than 30 days before the start date of the stay, full payment must be made at the time of booking.

CAMPSITE

The basic package includes 1 pitch intended to accommodate the tent, caravan or motorhome for 2 people and gives access to sanitary facilities and reception infrastructures. The maximum capacity of a pitch is 6 people including children.

ABSENCE OF RIGHTS OF WITHDRAWAL

In accordance with Article L.221-28 of the Consumer Code, Le Camping de Saint Aygulf informs its clients that the sale of accommodation services on a specific date, or according to a specific periodicity, is not subject to the provisions regarding the withdrawal period of 14 days.

CANCELLATION AND MODIFICATION

1. 1. Modification of your reservation:
The client can request the modification of his stay (dates, type of accommodation) upon written request to the campsite (courrier or email to: info@campingdesaintaygulf.fr) as long as availability and possibilities remain at the time of his request. No postponements will be accepted for the following season. In the absence of modification, the client must carry out their stay under the initial booking conditions or according to the terms of the insurance annulation. Any request for an increase in the duration of your stay will be made according to availability and according to the rates in force. Any request to reduce the duration of your stay is considered a partial cancellation and therefore non-refundable. In the event of an interrupted stay, abbreviated for one of the following reasons:

Closure of borders by administrative decision, administrative closure of the camping, limitation of travel to a number of kilometers by administrative decision not allowing to come to the camping, a good value of an amount corresponding to the regulations already made, valuable eighteen months, will be issued by the campsite. In case of refusal by the client of this voucher, it will be refunded, upon request, the corresponding amount deducted from the cost of the cancellation insurance if it has been taken out. Apart from the reasons mentioned above, any interrupted or abbreviated stay (late arrival, early departure) as a result of the client, cannot give rise to a refund or a voucher unless subscription is made to cancellation insurance and according to the general terms and conditions of sale thereof.

2. In case of cancellation due to the campsite, except in case of force majeure, the amounts paid for the reservation will be fully refunded. This cancellation cannot, however, give rise to the payment of damages.

3. Any cancellation request by the client must be communicated by mail to the campsite's postal address or by email. Cancellations sent by phone cannot be taken into account. Any cancellation leads to the immediate reinstatement of the reservation and the campsite reserves the right to offer the accommodation or camping site for rent again. For all other reasons, no repayments will be made without subscribing to cancellation insurance.

In case of cancellation by the client with a subscription to the cancellation guarantee, the amounts paid are covered by the guarantee according to the general terms and conditions.

YOUR STAY

Any change in the number of guests that may lead to a variation in the rental, fees and taxes must be confirmed upon arrival (tourist tax, additional person, compared to the capacity of the rental...). In the event of a false declaration by the client, this contract will be terminated automatically and the sums paid will remain payable to the lessor. The campsite reserves the right to refuse access to people arriving with a number of participants higher than the proposed package, at the capacity of the rented accommodation and if the names do not match the arrival.

1. ARRIVAL RENTAL :

The handover of the keys takes place between 3:00 PM and 7:00 PM and a deposit of €500 per ban-caire card will be required. In case of late arrival, please contact us by phone before 6:30 PM.

CAMPSITE :

The provision of the pitch is effective from 12:00 PM.

2. DURING YOUR STAY :

The campsite declines all responsibility in case of incident.

Each camper must have a civil liability insurance in order to cover goods and people. All customers must comply with the provisions of the interior regulations. Each tenant is responsible for the troubles and nuisances caused by people who stay with them or visit them.

The visitors

For security reasons, visitors must register upon arrival at the reception before visiting à a resident. Access to the aquatic area is strictly prohibited for all visitors. The management reserves the right to prohibit access to the campsite for non-registered persons. Any undeclared supplement (additional staff, dog...) and discovered during a check-up during the stay will be charged to the client from the date of his arrival.

3. DEPARTURE RENTAL :

On the day of departure indicated in your contract, the rental accommodation must be vacated before 10 o'clock in the morning. The deposit will automatically be canceled if the accommodation is returned in a perfect state of cleanliness, and the owner may check it; any broken or deteriorated object will be likely to be replaced, as well as the restoration if necessary.

The retention of the deposit does not exclude additional damage in the event that the fees are higher than the amount of it. In the case where the accommodation has not been cleaned before your departure, a cleaning fee of a minimum value of €200 including VAT will be requested.

DEPARTURE CAMPSITE :

The pitch must be vacated before 12 p.m.

PETS

RENTAL :

Only animals of – 10Kg (except dogs of the 1st and 2nd category) will be accepted for rental (excluding July - August), subject to an additional charge.

CAMPSITE :
